## Terms of service - Vinmonopolet API Services

These API Terms form a binding contract between you and Vinmonopolet. The Contract does not grant you rights to use any other of our tools/platform/interfaces.

Subject to the restrictions below, we grant you a non-exclusive, non-transferable limited license to access our APIs and documentation only as necessary to develop, test and support an integration of your applications with the Services. You may charge for your Application; however, you may not sell, rent, lease, sublicense, redistribute, or syndicate access to any of Vinmonopolet's APIs.

The information is provided through APIs by Vinmonopolet and its subsidiaries. Vinmonopolet do not warrant the completeness, accuracy, reliability, suitability or availability of the information, products, services, or related graphics contained in the API.

Vinmonopolet are not to be held liable for, the APIs being temporarily unavailable due to technical issues beyond our control.

Any reliance you place on information through APIs is therefore strictly at your own risk.

In no event will Vinmonopolet be liable for any loss or damage including, without limitation, indirect or consequential loss or damage, or any loss or damage whatsoever arising from loss of data or profits arising out of, or in connection with, the use of the APIs.

Through the APIs, you might be able to link to information delivered by third parties which are not under the control of Vinmonopolet. Vinmonopolet take no responsibility, and have no control over the nature, content and availability of this information.

## **Restrictions:**

Your network and the operating system and software of your servers, databases, and computer systems must be properly configured to securely operate your Application and store Data. Data must be stored and served using strong encryption. In addition, Applications and developers are prohibited from:

degrading or compromising security in any way

- providing access to Vinmonopolet in any fraudulent or unauthorized way, including bypassing or circumventing Vinmonopolet's protocols and access controls
